## Blue Badges

Parents and carers of disabled children may be able to apply for a Blue Badge for their child or young person if they are:

- ◇ 2 years of age or under and need to travel with bulky medical equipment or be close to a vehicle for emergency medical treatment
- ◇ Over 2 years of age and they receive the higher rate of the Mobility Component of Disability Living Allowance
- ◇ Registered blind
- ◇ Unable to walk or virtually unable to walk.

Blue Badges are **not** provided where a child or young person:

- ◇ Has a learning disability or mental health need, unless they cannot walk or have a lot of difficulty walking because of a permanent disability
- ◇ Has a temporary disability, e.g. if they are recovering from an operation or a broken limb.

## What Concessions Does a Blue Badge Provide?

By displaying the Blue Badge when travelling with your child, you will be allowed to park:

- ◇ **Free of charge and for as long as you need** at parking meters or pay and display bays and where other people can only park for a limited time in; Kingston council car parks; controlled parking zone permit bays.
- ◇ **For up to three hours** on single or double yellow lines, depending on certain rules and restrictions
- ◇ **Free of charge** in designated parking bays for Blue Badge holders in the borough. In many of the bays, Blue Badge holders can park without time limit but in some a maximum stay of either two or three hours is allowed.

## Applying for a Disabled Persons' Parking Bay Close to Your Home

The Council will consider applications for individual disabled persons' parking bays in residential areas. There are very strict criteria that have to be observed before a bay can be provided. Individual disabled persons parking bays are not normally provided within a controlled parking zone as blue badge holders can park close to their home without charge in any permit or shared use bay.
